# **Emergency Closings and Inclement Weather Policy**

With the exception of regularly scheduled holidays, the Criminal Justice Institute will be open for business from 8:00 a.m. to 5:00 p.m., Monday through Friday. Circumstances beyond our control—such as inclement weather, a national crisis, or other emergencies—do occur. On such occasions, the Institute may close for all or part of a regularly scheduled workday.

The Institute will close for inclement weather when the University of Arkansas at Little Rock (UALR) closes. All radio and television stations in central Arkansas will be notified through the UALR Office of Communications when the University is closed. On days declared to be covered by the inclement weather policy, an announcement of a delayed opening will be issued from UALR. Your personal safety is of utmost importance, and careful judgment should be used anytime inclement weather creates hazardous road conditions.

# **Smoking Policy/Tobacco Use Policy**

The Criminal Justice Institute is committed to providing a safe, clean, and healthy environment for our employees and visitors. It is, therefore, CJI policy to provide a tobaccofree work environment. The use of tobacco products (including cigarettes, cigars, pipes, smokeless tobacco, or other tobacco products and electronic cigarettes) is prohibited at all times:

- in all interior space on the CJI campus, including classrooms:

- in CJI vehicles. 3.)


This policy applies to all persons, including employees, faculty, students, visitors, contractors, subcontractors, and others on CJI properties. Signs are posted at all building entrances and displayed in prominent, visible areas advising employees and visitors of this policy. Tobacco-free zones apply on the grounds around all CJI facilities, whether or not signs are posted.

# **Concealed Carry Policy**

Pursuant to Act 226 of 2013, the Board of Trustees of the University of Arkansas System has expressly disallowed the carrying of a concealed handgun by licensed staff members or students within a University of Arkansas building. However, a certified law enforcement officer attending a class at the Criminal Justice Institute may carry a concealed handgun if that officer is: (1) Presently in the employ of a public law enforcement department, office, or agency; (2) Authorized by the public law enforcement department, office, or agency to carry a firearm in the course and scope of his or her duties; (3) Not subject to any disciplinary action by the public law enforcement department, office, or agency; (4) Carrying a badge and appropriate written identification issued by the public law enforcement department, office, or agency identifying him or her as a certified law enforcement officer; and (5) Not otherwise prohibited under federal law.

# **CJI's Library Services**

CJI's Library Services features numerous books, journals, periodicals, training manuals, reference materials, and DVDs/videotapes that can be utilized by law enforcement agencies across the State for in-house training, research, and professional development. Books and DVDs are loaned for a two-week period and can be requested and renewed by phone or email. For those who cannot visit the library in person, items can be mailed with the understanding that the requesting party will be responsible for the return postage only.



# **Course Eligibility**

Most courses and programs of the Criminal Justice Institute are available exclusively to sworn law enforcement professionals at no cost. In the event that a CJI course or program will be available to additional professionals within the criminal justice community, notification will be provided within the course or program description.

# **NON-SWORN LAW ENFORCEMENT** PERSONNEL AND NON-COMMISSIONED **CORRECTIONAL OFFICERS, JAILERS, AND DETENTION CENTER PERSONNEL**

For many years, CJI has received requests to make more classes available to non-commissioned correctional officers, jailers, detention center personnel and non-sworn law enforcement professionals. In response, the University of Arkansas Board of Trustees approved a fee-structure that allows CJI to expand the catalog of courses that are available to these vital members of the law enforcement community. Some of the courses are available at no cost while others have a small fee. See pages 58-59 for a complete listing of available programs.

#### **OUT-OF-STATE OFFICERS**

Select CJI courses are available for a fee to officers outside of the State of Arkansas. The expansion of these programs to law enforcement agencies outside of the State will not impact availability of programs for Arkansas law enforcement. However, we cannot guarantee slot availability for registrations received less than two weeks prior to the scheduled date of course delivery. Therefore, please register for classes as early as possible and respond to any course confirmations you may receive.

Course payment must be received no later than three weeks prior to the class start date. Agencies may substitute participants with prior approval only. Refunds will be granted up to 30 days before the date of the course. A \$25 processing fee will be deducted from the total refund amount. Requests for refunds received after this time will be considered on a case-by-case basis only.

# **Course Registration**

Individuals who plan to attend a CJI class must enroll by completing a CJI registration form and submitting it to the Institute. Please note that enrollments for in-state law enforcement will be accepted no sooner than 90 days prior to the scheduled date of each course.

# **Programs for Certified Arkansas Officers**



The Criminal Justice Institute collaborates with 22 colleges and universities across the State to expand higher education opportunities for Arkansas law enforcement. Through two unique programs—Crime Scene Investigation and **Law Enforcement Administration**—law enforcement personnel can now obtain Certificates of Proficiency, Technical Certificates, and Associate of Applied Science (AAS) Degrees in fields of study specific to the law enforcement profession. (See pages 8-13 for complete details about these programs.)

Both programs of study are available exclusively to Arkansas law enforcement officers who are actively employed within a law enforcement agency in the State. To successfully complete a program, participants will be required to take special courses through the Criminal Justice Institute along with general education courses from collaborating colleges and universities. Although officers will be required to pay all tuition and fees of the college or university, college credit for courses completed at CJI will be provided free of charge to Arkansas law enforcement personnel, allowing them to complete certificate and degree programs at a fraction of the normal cost. Information concerning financial aid opportunities, including Pell grants, student loans, and workforce improvement grants, can be obtained by contacting the financial aid offices of participating higher education institutions and the Arkansas Department of Higher Education (www.adhe.edu).

Examinations are administered in all CJI courses that are included in the Academic Certificate and AAS Degree Programs. If you are currently participating or intend to participate in these academic programs, taking these examinations when initially offered is required.

# **SCHOOL OF LAW ENFORCEMENT SUPERVISION**

The School of Law Enforcement Supervision (SLES) provides the tools law enforcement professionals need to advance as supervisors and administrators. This four-week development course is scheduled one week per month over a four-month period, and provides a unique opportunity for professionals to develop and cultivate leadership skills. Instructors for SLES are current and former law enforcement personnel and other professionals who are recognized for their expertise in their areas of instruction, to include several who are nationally recognized and are in high demand as presenters. Course topics include: Leadership and Communication Excellence; Research Strategies; Challenging the Organizational Culture; Organizational and Nonverbal Communication; Stress Management; Social Intelligence; Managing Media Relations: Domestic Terrorism; and a variety of legal topics. The curriculum includes weekly exams, an oral presentation, and a research paper. The top research papers from each class are posted on the CJI website.

Letters of nomination are required for officers to attend this specialized course. Nominated officers must have reached the minimum rank of sergeant to attend. Lodging assistance is available for a very limited number of participants who reside more than 50 miles outside of the metropolitan Little Rock area. Request for lodging assistance must be included in the letter of nomination. The nomination deadline is January 3, 2017.

# **CRIME SCENE TECHNICIAN CERTIFICATE PROGRAM**

#### The Crime Scene Technician Certificate Program (CSTCP)

is a series of six fundamental courses that introduce vital components of crime scene investigation. Participants are required to attend and successfully pass all six courses to receive their certificate. Upon completion of the program, participants will have exceeded the minimum requirements necessary to apply for national crime scene certification. All six courses of the program will be held at the Criminal Justice Institute.

#### The application period for the current session of this class

has ended. However, nomination letters for the 2018 session can be submitted to Dr. Cheryl P. May from your Chief of Police. Sheriff, Department Head or Director indicating how your participation in this program will benefit your agency and stating that he/she will support your attendance as well as ensure, to the best of their ability, your participation in all six courses.

# **WEEK ONE:** Crime Scene Management/ **Crime Scene Photography** January 10-13, 2017

On day one of this course, crime scene management, evidence potential and crime scene protocol will be emphasized. The following three days will cover digital photography techniques as well as general crime scene and forensic evidence photography. Participants will learn appropriate techniques for photographing a crime scene and related evidence. To adequately cover the topic of night photography, there will be an evening session conducted one day of this program. Photograph evaluations as well as written and practical examinations will be conducted.

# **WEEK TWO:** Impression Evidence February 7-9, 2017

Participants will be educated and trained to identify, document, and recover three-dimensional evidence. This will include footwear impressions, tire tracks, and fingerprints from crime scenes. Evaluation of photography assignments as well as written and practical examinations will function as assessment tools for individual performance.

## **WEEK THREE:** Latent Print Processing March 7-9, 2017

Basic latent print techniques will be emphasized. Participants will learn proper techniques for using fingerprint powder at crime scenes and also developing fingerprint and footwear impressions (two-dimensional). Chemical enhancement techniques will be demonstrated. Participants will be required to successfully photograph developed latent crime scene prints.

## **WEEK FOUR:** Biological and Trace Evidence April 4-6, 2017

This course illustrates the proper techniques used at crime scenes to identify, document, collect, and preserve bodily fluids and bloodstain pattern evidence. Chemical processing used to enhance blood impression evidence will also be included. Participants will photograph all results and will also be assessed in their ability to identify, document, and collect trace evidence (hairs, fibers, soil, safe insulation, etc.) using appropriate techniques.

# **WEEK FIVE:** Crime Scene Sketching, **Note Taking and Report Writing** May 2-4, 2017

The paper documentation phase of crime scene processing will be emphasized in this session. Participants will learn how to take paper notes, complete a comprehensive crime scene report, and produce a quality crime scene sketch. Basic techniques as well as computer applications will be used to accomplish these tasks. Participant evaluations will include written examinations, evaluation of notes taken, sketches, and report writing skills.

# **WEEK SIX:** Crime Scene Investigation June 6-8, 2017

Crime scene processing protocol will be emphasized in this capstone portion of the certificate program. Participants will be required to use previously acquired knowledge and skills to complete several mock crime scene scenarios, including those that may be conducted at night. Participants will be required to appropriately process all mock crime scenes and provide thorough presentations of their findings. A comprehensive written final examination and evaluation of photographs will function to assess individual performance and determine graduates of the program.

# **Equipment Requirements:**

Photography skills are critical in crime scene and evidence documentation. Each department must provide its agency representative a minimum amount of photography equipment to ensure successful participation in the program. The minimum photography equipment required for participation in CSTCP is listed below:

- Detachable Flash
- PC Cord
- Cable Release/Remote
- Spare Batteries for **Camera and Flash**
- Macro lens
- Filters (yellow, orange, red, and polarizing)

# NARCOTICS OFFICER **CERTIFICATE PROGRAM**

The Narcotics Officer Certificate Program (NOCP) was created to offer Arkansas law enforcement agencies the opportunity to provide specialized training to their narcotics officers, providing participants with the fundamental knowledge and skills they need to conduct basic narcotics investigations.

NOCP consists of five, three-day courses delivered once a month. Participants are required to attend all five components and pass all examinations to successfully complete the program. Core program topics include: Arkansas Drug Laws, Drug Identification and Classification, Methamphetamine, Managing Informants and Cooperative Witnesses, Search and Seizure, Investigative Techniques, Undercover Investigations, Pharmaceutical Diversion, Evidence Collection, Report Writing, Surveillance, Resources, Intelligence, Criminal Defenses, and Courtroom

Testimony. To participate in the program, an application letter must be submitted to Dr. Cheryl May from the applicant's Chief of Police, Sheriff, **Department Head or Director.**

# CJI's Online Programs

CJI's online courses cover a wide variety of topics and can eliminate many of the barriers law enforcement agencies face in finding advanced or specialized training opportunities for their officers. Officers who participate in online courses:

- Spend less time away from their agency...with classes conveniently available online, they can meet training and education goals without taking time away from work.
- Reduce travel costs...online programs completely eliminate fuel, dining, and lodging expenses.
- Choose their classroom...courses can be completed at any location-work or home.
- Move at their own pace...these programs are available to officers around the clock for a specified period of time.

Registration for online courses follows the same process as other CJI courses. The first step is to submit a registration request form for participation in an online course. Once the request has been processed, officers will receive notification of their enrollment in the course. Officers who have not participated in one of CJI's online courses will be assigned a log-in and password and directed to a special CJI website. Those officers who have participated in an online course will use their permanent log-in and password.

Online versions of CJI courses include features such as slides with audio narration, photographs, graphics, videos, review activities, scenarios, and recommended optional reading. Information about course completion requirements, such as required reading, and the log-in and password are emailed to officers. Course materials will be made available online for enrolled students.

Also, a Quick Start Guide is included as an attachment to the log-in email. This guide provides information necessary to successfully complete the online course, including general password information, error elimination, tips on navigating each module or topic within a course, common problems and issues that can occur, and contact information for assistance with any technical difficulties.

# LAW ENFORCEMENT PROFESSIONAL DEVELOPMENT:

# Animal Fighting/Animal Cruelty **Investigations ONLINE (3 Hours)**

This class is designed to help the student become a skilled animal cruelty investigator, learn search and seizure tactics, and improve his/her report writing skills. The program provides an overview of Arkansas's recently expanded Animal Cruelty law and investigative techniques related to animal investigations. Topics such as how to recognize animal cruelty and methods used to train animals will be discussed. Participants will be introduced to different categories of people involved in animal cruelty, clubs and associations that register dogs, and different types of evidence involved in dog and cock fighting cases.

# Domestic Violence ONLINE (7 Hours) 2017 DATES:

This program is designed to familiarize officers with the unique challenges they may face in domestic violence situations. Course topics will include the dynamics of abusive relationships, officer safety concerns, victim interviews, how to handle suspects, children and other witnesses, reporting, and probable cause leading to arrest and successful conviction, as well as a discussion of the use of Laura's Card and the Lethality Assessment which are now required by state law. The course will explore proper evidence collection and documentation, as well as civil orders of protection.

# **Ethics for Law Enforcement ONLINE (7 Hours)**

This course provides a comprehensive overview of ethical problems and considerations confronting law enforcement professionals. Using scenarios, students will utilize tools they acquired in this course to determine if an ethical decision was made.

This online introductory course is designed to assist first and second line supervisors, or individuals with promotion potential, in developing and applying sound management and leadership principles.

## LAW ENFORCEMENT PROFESSIONAL DEVELOPMENT:

## **NEW!** Human Trafficking Awareness ONLINE (3 Hours)

The U.S. Department of State estimates that over 14,000 victims are trafficked into the U.S. annually; more than half of these victims are children. This course will define human trafficking, distinguish between trafficking and smuggling, and review the Trafficking Victims Protection Act of 2000 as well as the Arkansas Trafficking Statutes. Victims of trafficking are largely hidden from sight by the nature of their condition, which leads to victims being overlooked when they appear in plain sight. Raising awareness of this hidden problem is a key element of this training. This training will describe a victim profile and tactics used for scouting and recruiting victims as well as provide indicators that a person is a victim of trafficking. Traffickers will be described using case examples and officers will learn how to identify and respond to victims with a trauma-informed approach. The course concludes with information on resources and assistance for domestic as well as international victims.

# Law Enforcement Response to Persons with **Behavioral Health Issues ONLINE (7 Hours)**

With funding and support from the Arkansas Association of Chiefs of Police, CJI is able to offer this training which is designed to give law enforcement officers a greater understanding of how to identify and interact with individuals suffering from behavioral health issues who they may encounter when policing. Keeping officer safety foremost, participants will explore policies, procedures, and protocols for officers and deputies to follow while dealing with this challenging situation. Course topics include identification of common behavioral health issues, officer safety issues, and interventions.

### **Principles of Supervision and Leadership ONLINE (24 Hours)**

Officers will learn techniques that can be used to guide the work of others as well as manage their own productivity. Course topics include types of authority, effective delegation, planning, training, the promotion process, performance evaluations, and the decertification process.

# Racial Profiling ONLINE (3 Hours)

American policing is facing a tremendous challenge: a widespread perception that police are routinely guilty of bias in how they treat minorities. Racial profiling by law enforcement agencies can lead to liability in a variety of ways. Many states, including Arkansas, have passed legislation addressing racial profiling. This online course reviews the law related to racial profiling and the challenges of addressing it. Specifically, this online course will provide Arkansas law enforcement officers with racial profiling training that is mandated in Arkansas Statute § 12-12-1404.

# LAW ENFORCEMENT PROFESSIONAL DEVELOPMENT:

#### **NEW! Use of Force ONLINE** (6 Hours)

Law enforcement officers are sworn to uphold the law and must attempt to apprehend those who violate it. Officers are required, however, to use only that amount of force that is reasonably necessary to make the apprehension. When excessive force is used, the officer, as well as the agency, may be held both criminally and civilly liable. This course will focus on case law and legislation which defines the amount of force that is lawfully available to officers in attempted arrest/seizure cases, as well as what the courts have defined as excessive force.

The course will also cover basic concepts of a civil law suit, the differences between civil lawsuits and criminal prosecutions, and how to prepare should an excessive use of force lawsuit be filed against an officer and/or the department. Use of force and excessive force will also be considered in the context of high-speed pursuit cases. The officer will be instructed in methods for improving his or her performance in the courtroom. In addition, there are sections dealing with the stages of the force continuum and with the concept of and techniques for de-escalation. Case scenarios involving the use of force, deadly force, and high-speed pursuits, force continuum, and de-escalation will be part of the interactive content.

### **CRIME SCENE INVESTIGATION:**

#### Crime Scene First Responder for the Uniformed Officer ONLINE (2 Hours)

The actions of first responding uniformed officer directly impacts the solvability and prosecution of criminal cases. Officers can inadvertently lose, destroy, or overlook critical evidence in the performance of their many duties as a first responder. In this course, officers will learn basic techniques for securing a crime scene and how to properly preserve evidence. Common investigative mistakes and solutions will also be discussed. This course is geared toward uniformed patrol officers, though new investigators and crime scene personnel will also benefit. This course was developed in collaboration with the International Crime Scene Investigators Association.

# Crime Scene Investigation ONLINE (12 Hours)

This online course provides a basic, introductory overview of crime scene investigation. A general synopsis of forensic evidence and how to properly secure, protect, and process a crime scene will be discussed. Investigators will learn the basics of the proper steps of crime scene investigation from the initial walk-through and scene evaluation to the crime scene documentation that includes note taking, photography, sketching, and final report. Types of evidence and their respective evidence potential will also be discussed. This course will benefit detectives/investigators, new crime scene specialists, and patrol officers who perform both patrol and investigative duties. Students will be required to complete Crime Scene First Responder for the Uniformed Officer ONLINE prior to registering for this course.

# **ILLICIT DRUG INVESTIGATION AND AWARENESS:**

# The Arkansas Methamphetamine Challenge for Law Enforcement Executives ONLINE\* (7 Hours)

This online course, developed in cooperation with the Arkansas Sheriffs' Association and the Arkansas Association of Chiefs of Police, provides an overview of the meth problem in Arkansas. A management perspective of awareness, employee safety, equipment, training needs, and reporting issues are emphasized to assist law enforcement executives and local municipal officials to most effectively combat meth production and abuse in their communities. Legal and liability issues, online resources, community awareness, drug abuse treatment and effective agency response to drug endangered children are included.

# **Drug Endangered Children Awareness ONLINE\*** (7 Hours)

This course examines the advantages for collaborative working arrangements at the local level between law enforcement, Division of Child and Family Services and other social service agencies when working cases that involve children living in homes where illegal drug activities occur. Participants will learn the history of the DEC movement nationally, the general history of drug use in the U.S., the effects and dangers of children living in homes where drugs are being used, manufactured or sold, drug recognition information and the advantages of local collaboration. Information about the Arkansas DEC Alliance will be shared and the Arkansas definition of drug endangered children will be explained.

# **Methamphetamine Awareness, Identification, and Safety** for First Responders ONLINE\* (7 Hours)

This course provides basic meth awareness and safety education for front-line officers and first responders who may come in contact with a clandestine laboratory. Participants learn to recognize precursors, equipment, and supplies used in the manufacture of meth and gain an understanding of the unique hazards of clandestine laboratories and receive critical information that will reduce their chances of injury.

# Methamphetamine Awareness, Safety, and Identification for Parole and Probation ONLINE\* (7 Hours)

This course provides basic meth awareness and safety education for Parole and Probation officers and first responders who may come in contact with a clandestine lab. Participants learn to recognize precursors, equipment, and supplies used in the manufacture of meth and gain an understanding of the unique hazards of clandestine labs and receive critical information that will reduce their chances of injury. Meth user/abuser profiles and scenarios illustrating safety precautions for home visits will also be included.

### Methamphetamine Investigations ONLINE\* (14 Hours)

Topics also include use of confidential informants, undercover investigations, "knock and talks," search warrants, drug trafficking organizations, legal issues, and drug endangered children.

## **SCHOOL SAFETY:**

# Autism Spectrum Disorders: Law Enforcement Response ONLINE (7 Hours)

Law enforcement officers will inevitably come into contact with an individual with autism. Therefore, it is vital that officers become skilled in the recognition of behavioral symptoms of these conditions and develop effective communication and response strategies. This course provides fundamental information about what autism is, its associated behavioral characteristics, effective interpretation of behavior, risk management for both the officer and the individual with autism, and communication. It will also address the high victimization rate experienced by people with autism, and provide tips for law enforcement officers charged with preventing and investigating these incidents.

### Identifying and Preventing Bullying ONLINE (3 Hours)

Bullying continues to be a problem for our schools and can interfere with a student's ability to receive the quality education they deserve. Changing bullying behavior requires a coordinated approach between administration, teachers, counselors, parents and students. School resource officers are also in a unique position to help identify and eliminate bullying behavior in schools. Knowing how to identify and address bullying behavior is essential to solving the bullying problem. This course is designed to help school resource officers and school personnel define bullying, recognize the warning signs of bullying, learn bullying statistics and myths, identify Arkansas statutory efforts against bullying, identify key roles in bullying events, and learn what schools can do in bullying prevention efforts.

## School Safety Refresher ONLINE (6 Hours)

This online course contains a combination of topics that school resource officers and school personnel could apply in their daily duties while working on a school campus. Participants will gain critical information regarding law enforcement on the school campus, hone their professional knowledge, and review Arkansas school and juvenile laws that are commonly associated with preventing or responding to crimes occurring on school campuses. Areas addressed include search and seizure, juvenile law, juvenile court, bullying, autism and weapons on campus.

#### School Site Safety Assessment ONLINE (3 Hours)

Planning and conducting a school site assessment is an important step in ensuring school security. This course was designed to build awareness of the process and stress the importance of conducting school site assessments. The course addresses the steps that should be taken in conducting a school site assessment including: assembling an assessment team, conducting a school crime assessment, conducting a school safety survey, controlling access into the school, developing a school security system, developing a site assessment checklist, and completing the school site assessment report.

## **SEXUAL ASSAULT INVESTIGATION:**

# **Introduction To Sexual Assault Investigation** For The Rural Investigator ONLINE (21 Hours)\*

The response to, and investigation of, sexual assault crimes requires a victim-centered approach as part of an effective investigation. This course is designed to enable rural officers to better understand the impact of sexual assault upon victims as well as apprehend the offender. Course topics include recognizing victim trauma, understanding the medicalforensic exam process, using effective victim interviewing techniques, and strategies for investigating and preparing sexual assault cases for prosecution. All Arkansas law enforcement personnel, including investigators, are eligible to participate in this course, regardless of agency size.

# **Introduction To Sexual Assault Investigation** For The Rural Executive ONLINE (18 Hours)\*

Rural law enforcement executives have the opportunity to have a significant influence on those they supervise and on their community's attitude toward sexual assault. They are responsible for creating and maintaining an environment that supports a victim-centered response to sexual assault. This course will enhance the capability of rural law enforcement personnel to manage and investigate sexual assault cases in their community. Course topics include the dynamics of sexual assault, victim trauma, the benefits of a team approach to sexual assault investigation, departmental sexual assault policies and procedures, the medicalforensic examination, alcohol/drug-facilitated sexual assault, media relations, and sexual assault case development from the prosecutor's perspective. All Arkansas law enforcement executives are eligible to participate in this course, regardless of agency size.

# FORENSIC SCIENCES AND **COMPUTER TRAINING DIVISION**

#### The Forensic Sciences and Computer Training Division (FSCTD)

provides training opportunities for Arkansas law enforcement personnel that enhances their crime solving knowledge, skills, and abilities through coursework and practical exercises that emphasize forensic science and computer applications.

Forensic and crime scene courses are designed to emphasize student participation and competency assessment by providing hands-on exercises, evaluation, and the utilization of state-of-the-art forensic, computer, and educational equipment. The quality of the forensic courses is further enhanced by the expertise and real-world law enforcement experience of our instructors. Through these courses, the Arkansas law enforcement community will continue to acquire skills to help them maximize the identification, documentation, collection, and preservation of physical evidence, ultimately solving more cases, thus enhancing the quality of life for the citizens they protect and serve.

The forensic and crime scene courses offered range from introductory level classes for newer investigators and patrol officers, to more specialized courses for those who regularly process crime scenes. The courses will provide in-class activities and mock crime scenes to enhance law enforcement personnel's knowledge and understanding of the proper procedures and techniques needed to preserve and document the critical physical evidence in a forensic investigation leading to an arrest and conviction of the offender.

CJI's Computer Training courses provide an important avenue for agency heads to ensure their personnel receive the training needed to effectively utilize this technology. With proper training, computer technology can decrease the time required to prepare reports and other administrative documents needed by law enforcement personnel such as data compilation and analysis, case management, database design and management, and communications. CJI offers a wide variety of courses to train law enforcement personnel to meet the changing needs of technology as more agencies implement computer applications to facilitate administrative, case management and investigative functions. Computer investigative/forensic classes are also offered, which include hands-on training. CJI has partnered with ICAC (Internet Crimes Against Children) to train law enforcement in various types of computer crimes.



# FORENSIC SCIENCES/CRIME SCENE

The Forensic Sciences Program at the Criminal Justice Institute enhances the training available to Arkansas law enforcement personnel who perform investigative and crime scene functions for their agencies. Through specialized course offerings taught by nationally and internationally recognized instructors, investigators and first responders can acquire or enhance their knowledge and skills to help maximize the value of physical evidence collected at crime scenes. Combining lecture and practical exercises, investigators learn proper procedures and techniques in the identification, documentation, collection and preservation of critical evidence and, in doing so, ultimately solving more and preventing crimes in the communities that they protect and serve.

CJI offers a nationally unique training facility, containing state-of-the-art educational equipment that offers course participants exposure to cutting edge technology. A large lab containing fingerprint processing equipment, 5 indoor mock crime scene rooms, a wooded area utilized for outdoor crime scenes and casting exercises, as well as an outdoor building that can be used for blood spatter exercises, enables the participants of CJI's forensic sciences courses to gain invaluable real life training experiences.

# Forensic Sciences

#### BASIC CRIME SCENE PROCESSING (21 Hours)

Processing a crime scene requires numerous skills. This three-day course will employ hands-on exercises focusing on the recognition, documentation, recovery, and preservation of physical evidence. Practical application of the techniques and procedures learned will be demonstrated through a mock crime scene exercise conducted on the last day of the program. This course will benefit patrol officers and new members of crime scene specialty units with minimal crime scene investigation experience. Participants should wear casual clothing that could become soiled during practical exercises. Students are strongly encouraged to bring a digital camera (digital SLR preferred), standard lens, macro lens (if available), batteries for camera and flash, digital media, off camera flash, remote flash cord, tripod, and a flashlight.

# **BASIC DIGITAL PHOTOGRAPHY (10 Hours)**

Using a combination of lecture, demonstration, and hands-on exercises, this day and a half course will explore basic photography techniques and concepts. These concepts include: camera modes and settings, effective use of light, macro photography, night time photography, and the basics of crime scene photography. Students are required to bring a DSLR camera with standard lens, macro lens (if available), batteries/charger, digital media, off camera flash, flash cord, tripod, and flashlight. To incorporate night photography exercises the first day of class will be from 1:00 p.m. to 9:00 p.m.

#### **NEW! COLD CASE FORENSICS** (14 Hours)

This two-day class will assist the investigator develop techniques and strategies in solving cold case homicides within their agencies. Students will learn what a cold case unit is, how to form a unit, and the key elements necessary to operate a cold case homicide squad. Topics covered include how to evaluate physical evidence collected at the original crime scene, what new technological advances exist that may help solve the crime, and how to determine what should be resubmitted for further analysis.

Students may also bring a cold case file to be analyzed. The target audience for this class is Detectives/Investigators.

# **NEW!** CRIME SCENE INVESTIGATIONS FOR SEXUAL ASSAULTS (14 Hours)

Sexual assault crime scenes usually comprise three primary sources of the evidentiary focus: the scene, the victim, and the suspect. This two-day course will enhance the skills, knowledge, and abilities of the first responder and detective/ investigator whose duties include investigating these types of crime scenes. The course will focus on the initial response, documentation, collection, and packaging of various types of physical and biological evidence.

# **CRIME SCENE FIRST RESPONDER** FOR THE UNIFORMED OFFICER ONLINE (2 Hours)

The actions of first responding uniformed officer directly impacts the solvability and prosecution of criminal cases. Officers can inadvertently lose, destroy, or overlook critical evidence in the performance of their many duties as a first responder. In this course, officers will learn basic techniques for securing a crime scene and how to properly preserve evidence. Common investigative mistakes and solutions will also be discussed. This course is geared toward uniformed patrol officers, though new investigators and crime scene personnel will also benefit. This course was developed in collaboration with the International Crime Scene Investigators Association.

### **CRIME SCENE INVESTIGATION ONLINE (12 Hours)**

This online course provides a basic, introductory overview of crime scene investigation. A general synopsis of forensic evidence and how to properly secure, protect, and process a crime scene will be discussed. Investigators will learn the basics of the proper steps of crime scene investigation from the initial walk-through and scene evaluation to the crime scene documentation that includes note taking, photography, sketching, and final report. Types of evidence and their respective evidence potential will also be discussed. This course will benefit detectives/investigators, new crime scene specialists, and patrol officers who perform both patrol and investigative duties. Students will be required to complete Crime Scene First Responder for the Uniformed Officer ONLINE prior to registering for this course.

#### **CRIME SCENE TECHNIQUES AND INVESTIGATION (50 Hours)**

This five-day, 50-hour course provides instruction in all of the vital components of crime scene investigation and techniques of evidence processing. The training will include several topics starting with crime scene responsibilities, proper photography techniques, how to use a camera in various manual modes instead of just automatic, plus macro and night photography. Additional topics of training include latent print processing, biological, trace, impression evidence, crime scene measurements and sketching, and proper evidence documentation. Hands-on exercises will focus on the recognition, documentation, processing, recovery, and preservation of physical evidence. Participants will apply learned techniques during a mock crime scene exercise conducted on the last day of the program.

This course would benefit personnel who want to have a better recognition of potential evidence, those who will be responsible for processing crime scenes themselves, or recently assigned crime scene technicians/CSI's who have not had formal training. Participants will be required to study and review course work prior to attending the class and attend a night photography session. Participants should wear casual clothing that may become soiled during practical exercises. Students are required to bring a digital camera (digital SLR preferred) with instruction manual, standard lens, macro lens (if available), batteries for camera and flash, digital media, off camera flash with instruction manual, remote flash cord, tripod, and a flashlight.

# Forensic Sciences

#### CRIME SCENE DIGITAL PHOTOGRAPHY AND IMAGING (28 Hours)

This course is intended for individuals who are actively working in law enforcement and who have a basic knowledge and understanding of Adobe® Photoshop.® It is recommended that all individuals have a minimum of two years' experience working in their respective forensic environment. Upon completion of this program, attendees will have a thorough understanding of forensic digital imaging concepts and how various image processing techniques can aid in the investigative process. At the end of each block of instruction, students must successfully complete a practical exercise to demonstrate that the required learning objectives were achieved.

#### **NEW! SCENE PD** (7 Hours)

Scene PD is a complete crash and crime scene diagramming tool for officers and investigators. The program employs a large library of objects to quickly and accurately diagram simple to complex crime scenes and traffic accident scenes. This one-day class will introduce the participant to this diagramming software and provide information on how Arkansas police agencies may acquire this software program at no cost.

#### **SHOOTING SCENE INVESTIGATION (21 Hours)**

Through a live fire event exercise, utilizing a variety of weapons, participants will be able to construct their own mock crime scenes. Using these mock crime scenes, participants will determine bullet paths, ejection patterns, and glass fracture patterns. Types of firearms, firearm terminology, angle of penetration, and shot sequencing will also be discussed.

Eye and ear protection, and a bullet resistant vest are MANDATORY for attendance. Participants should wear casual clothing that may become soiled during practical exercises. Students should also bring a digital camera (digital SLR preferred).

# **NEW! SUDDEN UNEXPLAINED INFANT DEATH INVESTIGATIONS (8 Hours)**

This eight-hour course teaches death scene investigators how to conduct a comprehensive infant death scene investigation. Investigators learn how to correctly document infant crime scenes, conduct witness interviews and doll re-enactment, and to develop a narrative report for the forensic pathologist. Topics covered include an overview of multiple causes of sudden, unexplained infant death, infant growth and development milestones, investigative data collection, infant scene investigation, and pre-autopsy report. Rotating breakout sessions include vicarious trauma and two scenario and doll re-enactment sessions.

#### **USING FORENSIC LIGHT SOURCES (21 Hours)**

The primary purpose of this course is to identify and demonstrate the uses of forensic light sources with photography. Students will be instructed on using the forensic light source to locate difficult evidence to include biological, hairs, fibers and enhancement of fingerprints in the lab and on crime scenes. Participants are encouraged to bring their own light source. Students are required to bring a digital camera (digital SLR preferred) with instruction manual, standard lens, macro lens, batteries for camera and flash, digital media, off camera flash with instruction manual, remote flash cord and a tripod.

# CRIME SCENE INVESTIGATOR CERTIFICATE

To provide Arkansas law enforcement personnel with an additional opportunity to continue and advance their professional growth and development in crime scene investigation, CJI developed the Crime Scene Investigator Certificate. Earning this certificate requires successful completion of the Crime Scene Technician Certificate Program, the Advanced Crime Scene Technician Certificate Program, and eight additional specialty courses. # COMPUTER TRAINING

CJI's Computer Training courses assist law enforcement personnel in acquiring the knowledge and skills necessary to effectively utilize computer technology in administrative and investigative activities. Computer software programs presented in CJI's computer courses teach participants to build reports, worksheets, presentations, graphs, charts, tables, and databases through hands-on, step-by-step instruction using law enforcement examples. Partnering with ICAC (Internet Crimes Against Children), CJI provides several investigative/forensic computer classes offering investigative software and hands-on exercises.

# **ADVANCED MICROSOFT EXCEL: DATABASE FEATURES (7 Hours)**

Microsoft Excel has built-in database management capabilities, allowing users to treat a worksheet or portions of a worksheet as a database. Using Microsoft Excel as a database allows users to enter, edit, locate, sort, filter, and analyze information. Officers will learn importing and exporting data skills; how to use advanced filters to create more advanced conditions to filter a data list; how to create pivot tables to vary one or two values in a formula and display all possible results in a table or chart format; how to use auditing tools to find and correct errors; how to perform forecasts and projections using Goal Seek and Scenarios; and how to use the Solver to solve problems by working backwards. Major topics to be covered include: Working with Databases; Managing Data; Importing and Exporting Data; Using Dynamic Data; Working with the Data Form; Using Advanced AutoFilter; Creating Pivot Tables; Conditional Formatting; Grouping and Outlining Data; Forecasting and Problem Solving; and Sharing, Locking and Protecting Workbooks.

# **Computer Training**

#### **BASIC NETWORK INTRUSION INVESTIGATIONS (32 Hours)**

BNII covers the skills and techniques involved in responding to a network security incident. The course focuses on the identification, extraction, and detailed examination of artifacts associated with network and intrusions. Memory analysis, host machine forensics, network traffic and log analysis, malware analysis, and virtual machine sandboxing are covered through lecture, discussion, and hands-on exercises. Additional topics include key cybersecurity concepts and issues, as well as the various classifications and types of network attacks.

- Introduction to cybersecurity.
- Network traffic analysis. The OSI and TCP/IP models. Monitoring, capturing, and parsing artifacts from PCAP files.
- Network attacks. Attack types (insider threat, opportunistic, targeted, advanced persistent threats, blended attacks). Examination of artifacts from keystroke logger, brute force attack, privilege escalation, remote access, data tampering, data exfiltration, botnet, and DDoS attacks.
- Investigative techniques. Live machine triage and the order of volatility. Capturing volatile data. Best practices for data analysis.
- · Hands-on experience. Host machine triage, memory analysis, network traffic and log analysis, malware analysis, and virtual machine sandboxing.

#### **COMPUTER FAST FORENSICS (21 Hours)**

This course is intended for computer forensic specialists/digital evidence examiners whose duties include the examination and analysis of digital evidence in high-technology crimes. It focuses on specific tool sets designed for rapid traversal of data and identification of evidential items of interest, both at the scene and later in a controlled environment. The course includes presentations and hands-on instruction on such topics as live machine and dead machine examinations, safe booting a GNU/Linux forensic platform, creating forensicallysound copies of digital media and mounting them for examination, conducting text and data searches, capturing volatile data (RAM imaging), obtaining user and computer information for use in the investigation, recovering certain passwords, identifying hidden data, and using hash algorithms.

The course was designed for students who already have a fundamental grasp of basic computer components and how to operate a computer using the Windows operating system. The student should come prepared with the prior knowledge and skills necessary to respond to an electronic crime scene and to safely and methodically collect and preserve items of evidential value that may be used in court proceedings. Basic computer skills and identifying/seizing electronic evidence will not be covered.

This two-day course will explore the various applications for smartphones and external equipment that can be utilized to document crime scenes. Smartphones are word processors, digital cameras, video recorders, and dictation devices all in one. Hands on instruction with real time crime scene applications and use of satellite imagery will be utilized. Other topics covered include legal parameters, shortfalls, case documentation, and crime scene sketches. This course is perfect for the patrol officer or investigator who has to process crime scenes and may not have access to a DSLR camera.

The Law Enforcement Management Division (LEMD) delivers courses and educational opportunities designed to enhance the knowledge, skills, and abilities of law enforcement professionals that also enhances the professionalism and proficiency of police in Arkansas. The ever changing demands on the criminal justice system create new and difficult challenges for leaders, supervisors and managers at all levels of law enforcement. LEMD presents courses to meet those challenges and prepare the professional officer for advancement. Course offerings emphasize effective supervision or management within the agency, enhanced interaction with their communities, officer safety, and the development of additional education and skills that benefit the law enforcement profession and the communities they serve and protect.

Courses are scheduled around the State in an effort to provide every officer an opportunity to receive advanced management education and training, eliminating the expense of extended travel. Grants from the Arkansas Attorney General's Office will enable us to continue to offer programs for Animal Fighting/Animal Cruelty Investigations and Officer Safety.

The Law Enforcement Management Division is offering two new classes in this schedule and has recently developed two new online courses as well. The new courses are Civil Rights and Fair and Impartial Policing for Command Staff, and the recently developed courses available online are Human Trafficking Awareness ONLINE and Use of Force ONLINE.

Individual organizational standards should serve as the backdrop for law enforcement leaders' expectations, and those should be enforced equitably and consistently across the board. Advanced Supervision and Leadership aims to give the experienced law enforcement manager the tools he/she will need to continue to advance strong supervision practices. This three-day course will tackle topics such as effective communication skills, leadership that makes a difference, managing problem employees, and stress and the workplace. This course is designed for all certified law enforcement officers, especially those who are promotable or those who are currently serving as supervisors.

# ANIMAL FIGHTING/ANIMAL CRUELTY **INVESTIGATIONS ONLINE (3 Hours)**

This class is designed to help the student become a skilled animal cruelty investigator, learn search and seizure tactics, and improve his/her report writing skills. The program provides an overview of Arkansas's recently expanded Animal Cruelty law and investigative techniques related to animal investigations. Topics such as how to recognize animal cruelty and methods used to train animals will be discussed. Participants will be introduced to different categories of people involved in animal cruelty, clubs and associations that register dogs, and different types of evidence involved in dog and cock fighting cases.

#### **CASE FILE PREPARATION** (6 Hours)

A prosecutable case may be lost in court due to inadequate case file preparation or an insufficient follow-up investigation. The objective of this sixhour course is to give law enforcement officers guidance in effective preparation of case files for prosecution and trial. Through hands-on training, this course will provide tools for the student necessary to create a professional and adequate case file. The participant will assemble raw data in an effort to illustrate how the arresting officer and the prosecutor must work together in a collaborative manner.

#### **CHILD ABUSE INVESTIGATIONS (7 Hours)**

Reports of abuse or neglect of children are often investigated by multidisciplinary teams. Law enforcement officers involved in child maltreatment investigations need to know what role they play in the process and what resources are available to them and the families involved. This one-day class, a collaboration of CJI and the Arkansas State Police, Crimes Against Children Division and the Arkansas Commission on Child Abuse, Rape, and Domestic Violence, aims to strengthen understanding of child abuse prevention and the most effective ways to aid children at risk.

# NEW! CIVIL RIGHTS (7 Hours)

U.S. law enforcement officers and other officials like judges and prosecutors have been given certain authorities by local, state, and federal governments—authority they must have to enforce the law and ensure justice in our country. These authorities include the ability to detain and arrest suspects, to search and seize property, to bring criminal charges, to make rulings in court, and to use deadly force in certain situations. Preventing abuse of this authority, however, is equally necessary to the health of our nation's democracy. That is why it is a federal crime for anyone acting under "color of law" to willfully deprive or conspire to deprive a person of a right protected by the Constitution or U.S. law. "Color of law" simply means the person is using authority given to him or her by a local, state, or federal government. This seven hour class will discuss "Color of Law" violations of the U.S. Constitution, hate crimes, and other Civil Rights violations.

# **COMMUNICATION EXCELLENCE IN** LAW ENFORCEMENT (7 Hours)

Law enforcement professionals interact daily with diverse groups of people. Agencies cannot afford to employ individuals who cannot communicate effectively with the populations they serve. Communication Excellence focuses on improving verbal skills in order to achieve law enforcement objectives and communication overall. Participants will develop skills that will enhance law enforcement professionalism, diffuse hostile behavior, help counsel victims, improve interviewing techniques, facilitate voluntary compliance, reduce problems and stress, reduce costs associated with verbal mistakes, and identify the central principles of dealing with difficult people.

# **COMMUNITY ORIENTED POLICING (6 Hours)**

These relationships can be critically important in times of heightened tensions due to crisis situations, as well as in developing effective two-way communication with citizens of the various communities in conducting routine police activities. Insights in developing citizen participation and ineffective law enforcement strategies to build citizen trust and dialog will be presented.

# **COPING WITH LAW ENFORCEMENT STRESS (14 Hours)**

Unmanaged stress can be very dangerous for the human mind and body. Policing, by nature, is stressful, and new challenges are presented daily. This two-day class is designed to help officers recognize the danger of stress. The first day of class deals with typical stressors law enforcement officers face. The likelihood of chronic stress in an officer's life and the negative effects it causes will be discussed. Several department studies dealing with officer suicide as a result of stress will be examined in class. Officers will be encouraged to find an outlet in their lives to help them manage the unavoidable stress they will encounter. A licensed psychologist co-facilitates day two of the class. At the conclusion of this course, officers will be able to identify one primary source of stress, identify three additional sources of stress, and recognize the importance of debriefing after stressful situations.

### **COURTROOM TESTIMONY (6 Hours)**

The arrest of suspects based on probable cause is voided if the arresting officer cannot skillfully and purposefully present his or her evidence in a court of law. This course offers insight on what makes a good witness, what qualifies a witness to be an expert, and what content needs to be included in an expert's testimony. Participants will be given trial testimony hints and tactics for handling drug, property crime, sexual assault, and violent crime cases.

### **CRIMES AGAINST THE ELDERLY (7 Hours)**

As medicine and technology advance, the percentage of older individuals in the U.S. population is increasing. With more elders, the numbers of elder abuse and elder neglect cases are also increasing. Inaccurate perceptions surrounding aging, perpetrators, dynamics, and causes of elder abuse/ neglect can lead to inappropriate and ineffective responses, putting victims at higher risk of harm. In many cases, law enforcement officers can use tools used in domestic violence, stalking, child abuse and sexual abuse cases to interview victims, and gather evidence. Ideally, participants should come to the training with knowledge about victim issues and abuser tactics and behaviors, as well as strategies and legal remedies that can be used in family violence cases. This training is designed for all certified law enforcement, but primarily first responders.

### **CRISIS NEGOTIATIONS (40 Hours)**

Hostile environments and crisis situations require that officers are able to diffuse potentially deadly scenarios with the least possible casualties. This forty-hour course is designed to provide law enforcement officers with the necessary tools to communicate with subjects as a trained crisis negotiator in volatile situations. Discussions include: What to Say and What Should Not Be Said; First Responder Negotiations; Techniques for Active Listening; Techniques for Suicide Intervention; and Suicide Prevention for Law Enforcement Officers. Emphasis will be placed on abnormal psychology theories.

This comprehensive look at cultural diversity aims to explore diversity plans, the bonuses of diversity, and tackle stereotypes.

### **DOMESTIC VIOLENCE (7 Hours)**

This program is designed to familiarize officers with the unique challenges they may face in domestic violence situations. Course topics will include: The Dynamics of Abusive Relationships; Officer Safety Concerns; Interviews of Victims; How to Handle Suspects, Children and Other Witnesses; Reporting; and Probable Cause Leading to Arrest and Successful Conviction. The course will explore proper evidence collection and documentation, as well as civil orders of protection.

### **EARLY INTERVENTION PROGRAMS (7 Hours)**

This seven-hour course is designed to instruct supervisors on the concepts, responsibilities and procedures associated with Early Intervention Programs (EIP). Administrators have recognized that a small percentage of officers are responsible for a large share of complaints that can damage an agency's reputation. EIP programs were implemented as a way to track and identify patterns of behavior and help prevent problem behaviors. This course will assist agencies in establishing EIP; identifying risk indicators; providing examples of action alternatives to assist officers; discussing pitfalls and other program problem areas; and highlighting the benefits of a viable EIP.

This training covers the science of bias, its implications for policing, and the elements of a comprehensive agency program to promote Fair & Impartial Policing. Assessments and reform in the realms of policy, recruitment and hiring, training, supervision and accountability, leadership, measurement, and outreach to diverse communities will be explored. Agency leaders will exit the training with an action plan to implement a comprehensive program to promote Fair & Impartial Policing.

# FIELD TRAINING FOR THE 21<sup>ST</sup> CENTURY (40 Hours)

Serving as a field trainer is one of the most important roles an officer may have in an agency. This course explores a variety of issues designed to help field training officers manage their probationary employees. Topics include: Six Functions of the Field Training Officer; Recruit Remediation; Documentation of Recruit Performance; Counseling and Motivation; Critical Training Issues — Cultural Diversity, Use of Force, Sexual Harassment and its Effects on Field Training; and Interpersonal Communication. In order to successfully complete the course, the student is required to attend all scheduled instruction and to obtain a passing grade on the final examination.

### **NEW! HUMAN TRAFFICKING AWARENESS ONLINE (3 Hours)**

The U.S. Department of State estimates that over 14,000 victims are trafficked into the U.S. annually; more than half of these victims are children. This course will define human trafficking, distinguish between trafficking and smuggling, and review the Trafficking Victims Protection Act of 2000 as well as the Arkansas Trafficking Statutes. Victims of trafficking are largely hidden from sight by the nature of their condition, which leads to victims being overlooked when they appear in plain sight. Raising awareness of this hidden problem is a key element for training. This training will describe a victim profile and tactics used for scouting and recruiting victims as well as provide indicators that a person is a victim of trafficking. The course also includes a description of how a victim accepts the lifestyle of a sexually trafficked person. Traffickers will be described using case examples. Officers will also learn how to identify victims and respond to them with a trauma informed approach. The course concludes with information on assistance available and resources for domestic as well as international victims.

### **INSTRUCTOR DEVELOPMENT (40 Hours)**

Keeping officer safety foremost, participants will explore policies, procedures, and protocols for officers and deputies to follow while dealing with this challenging situation. Course topics include identification of common behavioral health issues, officer safety issues, and interventions.

## **LEGAL UPDATE (7 Hours)**

Managing Informants and Cooperative Witnesses will specifically address recruitment, documentation, motives, control, legal issues, pitfalls to avoid, and other pertinent issues regarding confidential informants and cooperative witnesses. The supervisor's responsibility in the utilization of informants by his or her subordinates will also be discussed. This course is designed for supervisors, detectives, and those officers and deputies who work with informants and witnesses.

# **MANAGING INTERVIEWS AND INTERROGATIONS (7 Hours)**

The following topics will be discussed: REID Nine Steps of Interrogation; Common Interview Tactics; Criminal Investigations; and Definition of a Theme. This course is designed for investigators, detectives, and all certified law enforcement officers and deputies who may interview suspects and witnesses.

# **RACIAL PROFILING ONLINE (3 Hours)**

In a concise and convenient format, this online course reviews the laws related to racial profiling and the challenges of addressing it. Specifically, this online course will provide Arkansas law enforcement officers with racial profiling training that is mandated in Arkansas Statute § 12-12-1404.

Hood drills will be used to provide participants with intense experience fragments relating to sudden attacks, and force options.

Specifically, this risk management course will examine police culture and discuss what can be done today to avoid/minimize incidents from going wrong. Finally, participants will be shown how to mobilize (act) to do something about the real risks faced in their respective organizations.

# **STALKING** (7 Hours)

Stalking behaviors can be intimidating. The United States Department of Justice Office for Victims of Crime (OVC) defines stalking as repeated harassment or threatening behavior by an individual such as following a person, appearing at a person's home or place of business, making harassing phone calls, leaving written messages or objects, or vandalizing a person's property. Any unwanted contact between two people that directly or indirectly communicates a threat or makes a victim fearful can be considered stalking as well. New stalking laws in Arkansas, investigative practices, similar crimes associated with stalking, and different types of stalkers will be discussed.

# STREET SURVIVAL/CASUALTY CARE (3 Hours)

Good safety measures are essential for law enforcement professionals; however, it is equally important that officers learn skills that may help save their lives in the line of duty, or the life of another. This three-hour block of instruction will provide an overview and justification for Self-Aid/Buddy Aid programs and training. Participants will review the history and science behind the development of safety programs, review case studies, and learn key components needed in safety kits. At the conclusion of this course, participants will be able to render a number of safety techniques in potentially life threatening situations.

### **ADVANCED TRAFFIC ACCIDENT RECONSTRUCTION (40 Hours)**

This 40-hour course will give participants a working knowledge of what evidence and information is needed when arriving at the scene of a traffic crash, and how to safely obtain the needed information without further endangering the safety of themselves or victims. How to transfer evidence and information from traffic crash scenes to reports and diagrams will be covered. Additionally, participants will learn advanced skills in conducting accident investigations that aid in determining contributing factors that lead to the injury or fatality, how to develop a course of action to prevent future problems, and learn the importance of conducting a thorough investigation that will, if necessary, stand up in court.

# **USE OF FORCE** (6 Hours)

Law enforcement officers are sworn to uphold the law and must apprehend those who violate it; however, officers are required to use only that amount of force that is reasonably necessary to make the apprehension. When excessive force is used, the officer as well as his/her agency may be held criminally and/ or civilly liable. Discussion in this course will focus on case law and legislation which defines the amount of force that is lawfully available to officers in attempted arrest/seizure cases, as well as what the courts have defined as excessive force. Use of force and excessive force will also be considered in the context of high-speed pursuit cases. The officer will be shown methods for improving his or her performance in the courtroom. Case scenarios involving the use of force, deadly force, and high-speed pursuits will be used for class discussion.

# **WARRANTLESS SEARCH AND SEIZURE (6 Hours)**

Pressing circumstances may lead police officers to conduct warrantless search and seizures. This six-hour course reviews law enforcement encounters that lead to the search and seizure of contraband, where the requirements for a search warrant may be over-shadowed by other criteria. A review of pertinent court cases will be introduced to illustrate situations where warrantless searches and seizures may be authorized. Current trends in the law of search and seizure will be discussed.

# **ILLICIT DRUG INITIATIVE**

Of the many illicit drugs available to those who wish to abuse them, methamphetamine continues to be the most commonly abused illegal drug in Arkansas. Today, the majority of meth in Arkansas is manufactured in Mexican "super labs" and distributed through cartels. Due to its cheaper price and high purity, this form of meth is in high demand by drug dealers and users. With Arkansas being primarily a transit state, users and trafficking statistics have remained high, and steady over the last several years. These trafficking activities pose challenges and safety concerns for officers implementing enforcement activities.

Through the Special State Asset Forfeiture Funds, CJI will continue to make methamphetamine a key training priority for fiscal year 2017. The classes scheduled will provide a variety of curricular content and cover such topics as highway drug interdiction, street drug investigations, managing drug investigations, tactical drug operations, patron saints of the Mexican drug underworld, and management of drug informants. The classes to be presented have been developed by narcotics officers and interdiction specialists with decades of experience in their fields. One of two new courses to be delivered is Development, Management, and Control of Drug Informants. This course is designed to assist law enforcement officers and deputies in identifying potential informants, and successfully recruiting, developing, and utilizing them to assist in their drug enforcement activities.

In addition, we will offer courses on synthetic drug investigations, prescription drug diversion, as well as heroin and other opiates. The presence of heroin in our communities is becoming more common. It is important for law enforcement personnel to have knowledge of and information on heroin's different forms, how it is used, the risks associated with heroin use, drugs mixed with heroin, and the behaviors exhibited by those who use the drug. The second of two new courses will be Heroin: Combating, Investigating, and Preventing the Plague of Heroin in your Community. This course will provide strategies for combating, investigating and preventing the plague of heroin and the devastation it is causing across the US.

CJI, through federal funding, will continue to offer online methamphetamine-related courses each month for increased access and availability.

# **ADVANCED CRIMINAL INTERDICTION AND TRAPPED VEHICLE SCHOOL (21 Hours)**

This three-day course was designed to use three key topics to expand upon what was learned in CJI's Criminal Interdiction course. At the conclusion of this course, participants will have gained the appropriate skills needed to successfully interdict drugs in their jurisdictions.

Advanced Roadside Interview Techniques: Participants will learn how to effectively communicate during a roadside interview in order to detect deception and other attempts to cover criminal activity. The students will have the opportunity to view, analyze, and discuss actual videos of traffic stops and roadside interviews that are relative to the discussion topics.

Advanced Search Techniques and Current Trends: Through the use of videos and photographs, participants will study previous traffic stops made by the instructors in order to learn advanced search techniques and the current trends of drug traffickers. Participants will gain a working knowledge of search techniques by using high tech density meters, fiber optic scopes, upholstery tools, and wedges.

Currency and Asset Forfeiture: The dos and don'ts of currency and other asset seizures. The evaluation of every incident pertaining to currency seizures and the ethics surrounding whether or not it should be seized will be covered in depth.

# THE ARKANSAS METHAMPHETAMINE CHALLENGE FOR **LAW ENFORCEMENT EXECUTIVES ONLINE (7 Hours)**

This online course, developed in partnership with the Arkansas Sheriffs' Association and the Arkansas Association of Chiefs of Police, provides an overview of the methamphetamine problem in Arkansas. A management perspective of awareness, employee safety, equipment, training needs, and reporting issues are emphasized to assist law enforcement executives and local municipal officials to most effectively combat methamphetamine production and abuse in their communities. Legal and liability issues, online resources, community awareness, drug abuse treatment and effective agency response to drug endangered children are also included.

### **CRIMINAL INTERDICTION (21 Hours)**

This three-day course of instruction educates officers on the importance of effective highway interdiction. Participants learn the significance of going beyond the traffic stop by asking simple questions and paying attention to indicators of criminal activity. The importance of these indicators and current trends are outlined throughout the course. This course includes elements such as drug and criminal activity detection, proper observance of search and seizure laws, contamination issues, and ethical conduct. Information shared relates to what is commonly observed in Arkansas.

This 7-hour course is designed to assist law enforcement officers in identifying potential informants, and successfully recruiting, developing, and utilizing them. Recognizing the motives of confidential informants will help officers select and develop the most effective informants. Legal issues regarding the use of confidential informants as well as the differences between confidential informants and cooperating witnesses will be addressed. Methods for documenting informant activities and for maintaining the safety of informants will be stressed. Attendees will also learn to anticipate and minimize common problems with the use of informants.

# **NEW!** HEROIN: COMBATING, INVESTIGATING, PREVENTING THE PLAGUE OF HEROIN IN YOUR COMMUNITY (7 Hours)

Heroin is affecting many communities, youth and adults alike, across the US with no indication of slowing down. Law Enforcement is having a difficult time balancing their enforcement and investigative responsibilities while being tasked to administer medical life-saving treatments in the street. A lack of resources, lack of knowledge and lack of innovation has left police, communities and their medical personnel desperately attempting to combat the plague of heroin as it affects many members of their communities. This training class provides strategies for combating, investigating and preventing the plague of heroin and the devastation it is causing across the US.

The class will provide guidance on managing informants, learning investigative techniques, conducting tactical operations, and performing a search and seizure. Challenges that may arise will be addressed in each topic.

## **PRESCRIPTION DRUG DIVERSION (7 Hours)**

This course is designed to provide patrol officers, front line supervisors and detectives information pertaining to the investigation and prosecution of prescription fraud. Course discussions include how to effectively handle calls from pharmacists and doctor's offices, unique investigative techniques, how to read a prescription order, different agencies that can provide intelligence information in your investigation and Health Insurance Portability and Accountability Act (HIPPA) regulations. The differences between State and Federal statutes will be discussed to ensure that each officer is presenting the best possible case in court.

# **SYNTHETIC DRUG INVESTIGATION (7 Hours)**

Arkansas is on the cusp of a new era in drug use. The days of methamphetamine, cocaine, and marijuana are still with us, but there are many new classes of drugs that were not even heard of 10 years ago. Much of the focus will be on the widespread use and abuse of synthetic cathinones and cannabinoids. This course is designed to prepare front line officers on the dangers of new synthetic drugs as well as investigative techniques to combat these drugs that are now becoming available in Arkansas. Attendees will learn many of the new warning signs, dangers, and precautions associated with the growing use of these synthetic drugs. With the growing concern for the public's safety and the availability of such dangerous drugs, this course will help law enforcement mitigate the impact of these drugs on their communities. Other topics of discussion will include phenethylamines, tryptamines, hallucinogenic botanicals, and other new stimulants, depressants, and opioids that have recently emerged in Arkansas.

### **TACTICAL DRUG OPERATIONS (14 Hours)**

This course is designed to assist narcotics officers who may be required to deploy weapons during various situations which take place in low light circumstances including: serving search warrants, securing methamphetamine labs, and interdiction of methamphetamine. This course is designed to inform and train officers on the most efficient ways to deploy weapons in low light environments where officers have the highest probability of being injured. Participating officers will be tasked with the deployment and implementation of weapons in a variety of live fire range drills and force on force scenarios. These practical exercises will make use of Simunition® FX® marking cartridges and SecuriBlank™ training cartridges. During firearms training, officers must furnish the following items: tactical flashlight, handgun, holster, magazine pouch, 3 magazines, 150 rounds of ammunition, raid jacket or cover shirt, vest (body armor), APR (mask) and carrier, hat, ANZI approved eye and ear protection.

# TRAFFIC SAFETY PROGRAM

The Arkansas State Police Highway Safety Office provides grant funds from the National Highway Traffic Safety Administration (NHTSA) to support the Criminal Justice Institute's Traffic Safety Law Enforcement and Prosecutor Training Project, the central source of nationally recognized traffic safety certification courses for Arkansas law enforcement. Available programs include:

- DWI Detection and Standardized **Field Sobriety Testing**
- DWI Detection and Standardized **Field Sobriety Testing Refresher**

The Criminal Justice Institute also works with the State's Prosecutor Coordinator's Office to host an Impaired Driving Training Seminar.

In addition, the Arkansas State Police Highway Safety Office provides NHTSA grant funds to support the Law Enforcement Liaison Project. In this project Law Enforcement Liaisons (LELs) promote participation of Arkansas law enforcement agencies in two annual nationwide traffic enforcement-related campaigns titled "Click It or Ticket" (CIOT) and "Drive Sober or Get Pulled Over" (DSOGPO). These campaigns are promoted through on-site visits to agencies by the LELs to encourage participation and explain the process, if needed. Once the campaigns have been conducted, agencies receive awards for their participation. Previous awards have been Portable Breath Testers (PBTs) for DSOGPO and stalker radars for CIOT.

The law enforcement liaisons also participate in national and state law enforcement conferences. During these conferences the LELs interact with law enforcement executives and officers to promote the annual campaigns.

# SAFE SCHOOLS PROGRAM

The **Safe Schools Program** provides education, training, resources and technical assistance to all Arkansas law enforcement and education professionals responsible for school safety. CJI's comprehensive catalog of school safety courses assists law enforcement and school personnel in reducing violence and violence-related behaviors in Arkansas schools. A proactive approach to responding to crime and violence, both on the school campus and within the community, is emphasized.

Through a grant award from the U.S. Department of Justice-Office of Community Oriented Policing and funding from the Arkansas Attorney General's Office, the Institute provides basic and specialty school safety training courses for law enforcement (including school resource officers) and school personnel (including administrators, teachers, staff, counselors, and school security officers). # **JUVENILE TAKEOVER OF SOCIAL MEDIA: INVESTIGATIONS AND INTERNET SAFETY (7 Hours)**

Juveniles don't know a world without social media but do they know the dangers? Do we, as adults, know the dangers? Schools and families depend more and more on the Internet and computer usage for daily homework assignments and communication. Students today have easy access to cell phones, smart phones, computers, iPads and tablets. This two-part course will address the importance of school personnel and school resource officers in staying current on the Internet and social media sites being most used by juveniles. The morning session will address the latest trends, popular internet sites, text abbreviations and social network sites being utilized by juveniles. It will also discuss current social media trends and crimes related to our juveniles' use of social media sites, cell phones and computers. The afternoon session will discuss the explosion of social media applications and the dangers they present to today's youth with an emphasis on sexual exploitation of minors. Focus will be given to real-life investigations that have occurred in Arkansas to include a live demonstration on the means and methods employed by internet predators to entice and coerce minors into exploitative situations. Attendees will also receive tips and materials regarding social media-based investigations. This class will also address the legal implications associated with cybercrimes and specific social media sites.

The course material for Juvenile Takeover of Social Media: Investigations and Internet Safety has been updated, and the class will now be presented by two instructors.
